2019 sewer and water permit fee schedule
(Fees shown are only valid for the year 2019; please call for fees in different years.)
<b>Sewer and Water permits</b> for installation, replacement or repair shall be \$65 + 1.75% of the job valuation.
<i>(State surcharge is .0005 times the job valuation. Call the St. Louis Park Inspections Department at 952.924.2588 for state surcharges on all permits valued at \$1 million or more).</i>
When applicable, a plan review charge equal to 35 percent of the sewer and water permit fee will be added.
<b>Exceptions:</b>
Repair or replacement of a single sewer service or single water service for a single-family dwelling shall be \$100 + \$1* = \$101.
<i>*State surcharges are calculated at \$1 for single item permits issued under this exceptions.</i>
