Membership and Terms:

- (1) The City Council will not consider applications from regular full-time or part-time St. Louis Park employees, or seasonal, temporary, paid-on-call firefighter or contract employees if appointment could cause a conflict of interest.
- (2) The City Council will not appoint a board or commission member to serve concurrently on more than one board or commission (not including the Charter Commission), and commissioners may only serve one consecutive year as chair. Board and commission members cannot serve on the same commission as a member of the immediate family, registered domestic partner or members of the same household. Youth are exempt from this provision.

Conflicts of Interest:

No commissioner shall: (1) Enter into any contract with the city unless otherwise authorized by law. (2) Use their position to secure any special privilege or exemption for themselves or others. (3) Use their office or otherwise act in any manner which would give the appearance of or result in any impropriety or conflict of interest.

IMPORTANT INFORMATION CONCERNING YOUR APPLICATION

DATA PRIVACY NOTICE: Minnesota law requires that you be informed of the purposes and intended uses of the information you are providing on this application. Pursuant to Minnesota Statutes Section 13.601, your name, city of residence, employment history, volunteer work, awards and honors are public data and is available to anyone who requests the information.
